Castlewood City Council February 5, 2018

The Castlewood City Council met in regular session on the above date at 7:30 p.m. with the following members present: Mayor Paul Friske, Jeff Dahl, Ryman Dockter, Jeff Shepherd, Heather Schmit, Shawn Mullaney and Brian Ries. The meeting was called to order by the mayor.

A motion by Schmit and seconded by Ries to approve the agenda with all members present in favor and motion passed.

The minutes of January 2, 2018 were approved on a motion by Mullaney and seconded by Shepherd with all members present voting aye and motion passed.

The Council met as the Board of Adjustment for variances & special exception

Todd Kays, representing First Planning District, discussed with the board voting procedures for variances and special exception hearings. He answered any questions that the board or individuals had.

The variance hearing for Lowell Laue to have a 10' front yard variance instead of the 20' setback. The mayor asked if anyone present in opposition of the variance and no one in attendance was opposing the variance. A motion by Dockter and seconded by Mullaney to approve the variance with all members present in favor and motion passed.

The special exception hearing for Derek Woertink to replace his existing mobile home with a new mobile home. The mayor asked if anyone present was in opposition of the special exception and no one in attendance was opposing the special exception. A motion by Ries and seconded by Dockter to approve the special exception hearing.

The Council returned to regular session.

Discussion was held on the city selling Outlot J to a resident. The berm for the gully is on the north side of Outlot J. The city would like to have access to the berm if they were to sell it. A motion by Dockter to sell the lot with a covenant for the city to have berm access and have the resident make an offer on the property with a second by Mullaney. All members present in favor and motion passed.

Adam Rudebusch, president of the Economic Development Corporation, discussed a loan request. The loan request is from Don Plagman, owner of the Castlewood Corner Market, to replace freezers in the store. Loan request is between \$14,000 and \$16,000. The interest for the loan is 5% and with a 5 year payback. A motion by Mullaney and seconded by Dockter to approve the loan with all member present voting aye and motion passed.

Jenny Olson requested a moving permit for a new Governor's House to replace her existing house located at 101 S. Oak Avenue. A motion by Ries and seconded by Mullaney to approve the moving permit with all members in favor and motion passed.

NB Golf Cars, Hendricks, MN, had a few lease options for the 5 carts the golf course leases from them. Option #4 was for 5-2014 Club Cars for \$420.20 with a six year lease. The golf course currently pays \$625 per month for 5-2004 Club Cars. A motion by Ries and seconded by Schmit to rent 5-2014 Club cars and to allow the mayor to sign a six year lease with NB Golf Cars. All in favor and motion passed.

A supplemental budget for the General Fund in the amount of \$13,000 to cover the two year audit and \$1000 to cover office furniture for the library was presented. The \$13,000 will come from cash on hand and the \$1000 comes from a donation to the library. A motion by Ries and seconded by Mullaney to approve the first reading of the Supplemental Budget with all members present in favor and motion passed.

A motion by Ries and seconded by Dahl to approve the General Journal Entries with all members present in favor and motion passed.

A motion by Mullaney and seconded by Dockter to adjourn. The meeting adjourned at 8:15 p.m. with all members present in favor and motion passed.
