The second reading for Supplemental Budget 18-6 was approved on a motion by Dockter and seconded by Dahl with all members present voting aye and motion passed.

The first reading for Supplemental Budget 18-7 was approved on a motion by Mullaney and seconded by Shepherd with all members present in favor and motion passed. The second reading will be held December 3rd, 2018.

There were no building permits for October 2018.

The group health insurance for the employees does not have an increase for the next year.

The Economic Development received a request from Wanda and Lowell Laue for a new home incentive on their duplex that was built in 2017. The development board recommended denying the request because the incentive was not in place at the time of them building. A motion by Dockter and seconded by Mullaney to deny the new home incentive for the Laue's. All in favor and motion passed.

A letter from Maguire Iron on the inspection done in July of 2017 was presented to the council. Maquire Iron's recommendations are Interior Painting in the 2-3 years at a cost of \$38,000; Exterior Painting in the next 3-5 years at a cost of \$40,000; Sanitary upgrades \$3500; Safety upgrades \$8500. The last time the water tower was painted inside and outside was 2002. No action was taken at this time.

Liquor licenses for the Ship's Inn-on & off sale; and Castlewood Community Golf Course-on sale was presented. A motion by Dahl and seconded by Dockter to approve the liquor licenses with all members present in favor and motion passed.

A plat of Popham Addition for Brad and Tamara Popham was presented for approval. A motion by Dahl and seconded by Schmit with all members present voting aye to approve the following Resolution 18-6:
