## Castlewood City Council January 7, 2019

The meeting was called to order by the Mayor.

Public Comments were held at this time and no one appeared to comment.

Mayor's report - Mayor Ries reminded councilman that Legislative Day is being held in Pierre if anyone would like to attend.

There were not any building permits issued in December.

The Economic Development board had a new housing incentive request from Chase West who is building a new home in the Countryview Subdivision for \$5000. A motion by Mullaney and seconded by Barker to approved the housing incentive with all members present voting aye and motion passed.

Landon Vetter, representing the Economic Development Board, discussed Amelia Foster interested in purchasing Flinner's building. Discussion followed. A loan in the amount of \$127,800 which includes \$80,000 for building and \$47,800 for repairs contingent upon an inspection and appraisal are done and result in a favorable outcome. A motion by Dockter to preapprove the loan with a 15-year amortization with a 10-year balloon at 4.5% interest contingent upon the inspection and appraisal being done with a second by Dahl. All members present in favor and motion passed.

There are two positions open on the recreation board. The terms of Kelsi Langenfeld and Kyle Kooima are up for 2019. The finance officer is to put an ad in the paper for the two positions available.

Vacation request from city employees were held. Sheila Gerhold is requesting vacation from February 7<sup>th</sup> through February 13<sup>th</sup>. Rick Ries is requesting vacation from January 23 through January 29<sup>th</sup>. A motion by Schmit and seconded by Shepherd to approve the vacation requests with all members present in favor and motion passed.

2018 Golf Course report was held at this time. Superintendent Doug Gerhold discussed a huge tree on the #9 tee box that needs to be cut down. Kelly's Tree Service will lay the tree on the ground for \$200 and Gerhold will clean it up. Gerhold asked to purchase a tool box for the maintenance shed with a cost of approximately \$600 and he also needs to purchase some supplies for the course in the amount of \$500. The profit and loss for the golf course was presented to the council with a profit of \$10,276.02 for 2018. The council was also given a comparison report for all 4 years the city has owned it.

The investment report for the 4<sup>th</sup> quarter of 2018 was approved on a motion by Shepherd and seconded by Schmit with all members in favor and motion passed.

An update on the water study grant was presented to the council. The city was approved for the grant in the amount of \$8000.00 and the city's portion of \$2000.00 for a total of \$10,000.00.

The finance officer asked to have the carpets cleaned at the clubhouse, the meeting room in the community building and the carpet in the office. Council gave their approval.

A motion by Barker and seconded by Dahl to enter into executive session at 8:23 p.m. to discuss personnel with all members present in favor and motion passed.

A motion by Mullaney and seconded by Dahl to return to regular session at 9:25 p.m. with all members in favor and motion passed.
